INDEMNITY CUM DECLARATION BOND

2. I have visited the School campus and seen the facilities and have understood the admission guidelines completely. I have also read and understood the School rules and regulations and have found them to be appropriate and lawful and the same have been explained to me.

I, on my behalf and on behalf of my Child, our heirs, executors, administrators and legal representatives, further confirm that we shall not hold the Indemnified Parties responsible for any liability or proceedings arising out of handing over of the custody of my Child by the School or its staff to any person whose name appears on the record of the School as parent/guardian or any person authorized by them.
8. If any term of this Indemnity Bond shall, to any extent, be invalid or unenforceable, the remainder shall not be affected thereby, and each and every remaining term of this Indemnity Bond shall be valid and enforced to the fullest extent permitted by law.

9. By signing below, I acknowledge that I have carefully read this release and Indemnity Bond and, fully understand its contents, and agree to its provisions. I am aware that this is a release of liability, a waiver of claims, and an agreement not to sue, and a contract between me and the School, on behalf of myself and my Child. I am the parent of the Child and assure, and indemnify, the School that I am authorized to sign this release and indemnification.
