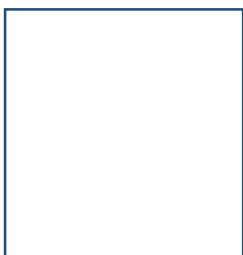

**INDEMNITY CUM DECLARATION BOND**

1. I, Mr. / Ms. \_\_\_\_\_ S/o. / W/o., \_\_\_\_\_ residing at \_\_\_\_\_ desire to admit my son / daughter, Master/ Ms. \_\_\_\_\_ (hereinafter referred to as "**Child**") having date of birth \_\_\_\_\_, over whom I have physical custody and control, to Class \_\_\_\_\_ in The Green Acres Academy / The Green Acres Pre Primary (hereinafter referred to as the "**School**").
  
1. I declare that I am the single mother of the Child. I have absolute custody and control of the Child. I state that it is my decision to be a single mother and I do not wish to disclose the name of the father of the child.
  
2. I am aware that as per the School rules and regulations, both parents have to be involved in the admission process and formalities of their child and that the admission form has to be signed by both parents, however, since I am the only parent of the child, I will be signing any and all documents required for the admission of the Child. Further, I state that no person other than me can claim to have any rights over my child in any capacity or be entitled to take any decision relating to my child.
  
3. I have visited the School campus and seen the facilities and have understood the admission guidelines completely. I have also read and understood the School rules and regulations and have found them to be appropriate and lawful and the same have been explained to me.
  
4. It is my humble request to the School to kindly accept my declaration as a single parent and grant admission to my Child.
  
5. I hereby agree to unconditionally and absolutely indemnify and keep indemnified the School, its management, principal, teaching and non-teaching staff, other employees and/or all such people who may be looking after the day-to-day activities of running the School and/or taking care of my Child ("**Indemnified Parties**"), of, from and against any claims, demands, costs, liabilities, obligations, penalties, expenses, damages, proceedings which the Indemnified Parties may suffer or incur or be put to by reason of or in direct or indirect connection with any acrimonious relations, separation or any other similar issues whatsoever between the father of my Child and me.
  
6. I, on my behalf and on behalf of my Child, our heirs, executors, administrators and legal representatives, further confirm that we shall not hold the Indemnified Parties responsible for any liability or proceedings arising out of handing over of the custody of my Child by the School or its staff to any person whose name appears on the record of the School as parent/ guardian or any person authorized by them.
  
7. If any term of this Indemnity Bond shall, to any extent, be invalid or unenforceable, the remainder shall not be affected thereby, and each and every remaining term of this Indemnity Bond shall be valid and enforced to the fullest extent permitted by law.
  
8. By signing below, I acknowledge that I have carefully read this release and Indemnity Bond and, fully understand its contents, and agree to its provisions. I am aware that this is a release of liability, a waiver of claims, and an agreement not to sue, and a contract between me and the School, on behalf of myself and my Child. I am the parent of the Child and assure, and indemnify, the School that I am authorized to sign this release and indemnification.
