### INDEMNITY CUM DECLARATION BOND

1. I, \_\_\_\_\_, son of [●] residing at [●] desire to admit my adopted son / daughter, Master / Ms. \_\_\_\_\_ (hereinafter referred to as "Child") having date of birth \_\_\_\_\_ to Class [\_\_\_\_] in The Green Acres Academy and for which I have signed the necessary acceptance papers for adoption with \_\_\_\_\_ NGO, to live in my foster care (copy of Certificate issued by said NGO is attached).
2. I declare that my application for adoption was approved by the Central Adoption Resource Authority. . I further submit that I am hopeful that the custody of the said Child will be granted to me very soon. I hereby agree and understand that this admission shall be purely temporary/provisional and the same shall be confirmed when I submit the Orders of the Hon'ble Court granting adoption of the said Child, failing which the admission shall stand cancelled .
3. I do hereby reiterate and declare that if due to any reason the Hon'ble Court rejects my case papers for adoption of the said Child, the admission of the said Child shall stand automatically cancelled.
4. I declare that I am a single parent of the child. I am aware that as per the School rules and regulations, both parents have to be involved in the admission process and formalities of their child and that the admission form has to be signed by both parents, however, since I will be the only parent of the child, I will be signing any and all documents required for the admission of the Child.
5. I hereby undertake that I shall immediately inform the School Authorities about any decision taken by the Hon'ble Court regarding adoption of the said Child and I hereby undertake to submit to the School Authorities the Certified copy of Order passed by the Hon'ble Court in connection with the adoption of the aforesaid Child within seven (7) days from the receipt of the Certified copy of the said Order.
6. I hereby undertake the financial responsibility for the Child including payment of yearly School fees till the said Child completes his education from the School.
7. I hereby agree to unconditionally and absolutely indemnify and keep indemnified the School, its management, principal, teaching and non-teaching staff, other employees and/or all such people who may be looking after the day-to-day activities of running the School and/or taking care of my Child ("**Indemnified Parties**"), of, from and against any claims, demands, costs, liabilities, obligations, penalties, expenses, damages, proceedings which the

Indemnified Parties may suffer or incur on account of rejection of my said adoption application by the Hon'ble Court.

8. I, on my behalf and on behalf of my Child, our heirs, executors, administrators and legal representatives, further confirm that we shall not hold the Indemnified Parties responsible for any liability or proceedings arising out of handing over of the custody of my Child by the School or its staff to any person whose name appears on the record of the School as parent/guardian or any person authorized by such parent.
9. If any term of this Indemnity Bond shall, to any extent, be invalid or unenforceable, the remainder shall not be affected thereby, and each and every remaining term of this Indemnity Bond shall be valid and enforced to the fullest extent permitted by law.
10. By signing below, I acknowledge that I have carefully read this release and Indemnity Bond and, fully understand its contents, and agree to its provisions. I am aware that this is a release of liability, a waiver of claims, and an agreement not to sue, and a contract between me and the School, on behalf of myself and my Child. I am the parent of the Child and assure, and indemnify, the School that I am authorized to sign this release and indemnification.
